

Information on Visitor Visas for Namibia

HOW TO APPLY:

Visitors can apply for visa in three ways

VISA ON ARRIVAL (RECOMMENDED):

Upon arrival at the Namibian port (s) of entry.

NOTES ON VISA ON ARRIVAL APPLICATIONS:

- All 33 affected countries are eligible to apply for visa upon arrival.
- Engagements are ongoing to provide for ATMs in the arrival areas.
- Credit card facilities (Master / Visa) are to be made available at every counter for ease of payment. **RECOMMENDED TO HAVE CASH ON HAND, IN SMALL BILLS**
- **MUST PRESENT A CERTIFIED PHOTOCOPY OF EACH PASSPORT (NOTORIZED COPY RECOMMENDED) see more on the next page**

NOTES ON ONLINE APPLICATIONS:

- MHAISS introduced online visa applications in 2022.
- All 33 countries affected by the visa requirement as from April 2025 may apply for a visa online.
- MHAISS is working on online payment modalities to ensure faster processing of online applications.
- **We find the online system to not be user friendly, and encourage travelers to submit their visa on arrival if the online application does not work**

IN PERSON:

Applications submitted to any Namibian embassies or consulates in your home country or - at any Namibian port of entry, or - at the Ministry of Home Affairs, Immigration, Safety and Security (MOHAISS)

NOTES ON IN PERSON APPLICATIONS:

- Continued in - person application at the Consular sections of Namibian missions abroad remains an option for applicants.
- New visa application form to be used.
- Consular sections to take note of changing requirements for supporting documentation.

VISA FEE PER PASSPORT HOLDER (TOURISM / HOLIDAY VISA) AND OTHER NOTES:

- Namibian Dollar N\$1600 (app US\$90) for citizens from non - African Union (AU) countries.
- These fees are subject to annual review.
- Visa application forms are being simplified to require only the necessary information.
- Visa application forms will double as both (1) arrival and (2) departure forms, thereby enhancing process efficiency. This same form will also be the Visa on Arrival application.

LIST OF REQUIREMENTS FOR VISA APPLICATION:

- Completion of the visa application form
- Each passport holder to complete a separate application form (including minors)
- **Certified photocopy of the passport from the country of origin (NOTORIZED COPY RECOMMENDED)**
- Proof of a confirmed return ticket
- Visa fees: N\$1600.00 upon approval, per person
- If you are a Family (Wife and Children with age less than 17 do not require uploading the Power of Attorney)
- IF INVITED (ONLY for work or volunteering, not for tourism): a. Invitation letter from the inviter (if invited) b. Deed of surety form signed by the inviter (if invited) c. Six (6) months bank statement from the inviter (if invited) d. Current status of the inviter (if invited)
